YPAC Art Gallery Timeline: Spring 2024 “Feathers, Fur & Fins”

The YPAC Gallery is having an open call for visual artists for our Fall 2023 exhibit.

To submit, please email a completed application with high resolution (300 DPI) image as JPEG or PNG, and completed Hold Harmless Agreement to mdickson@yucaipa.gov or turn in to YPAC Box Office (Tues-Fri. 4-7:30pm)

- *The YPAC Spring 2024 art gallery show, “Feathers, Fur & Fins,” is open to interpretation.*
- *No age limit. No residency limitation.*
- *Height and width of each piece is not to exceed 26” (including any framing) with a maximum depth of up to 8”; 10 lb. maximum per piece.*
- *Each applicant may submit up to four pieces.*
- **Application submission deadline: Monday, March 4, 2024**
- *Accepted artists will be notified by March 15, 2024.*
- *Accepted piece(s) must be completely dry upon submission to YPAC, and 2D pieces must be ready to hang by wire or eye hook(s). Artist may need to supply stand for any 3D piece, if necessary.*
- *Accepted pieces will need to be handed in Mar. 15th-Mar. 20th. The YPAC Box office can accept pieces Monday-Friday 4-7:30pm. To make an appointment outside these hours to drop off artwork, please email Mdickson@yucaipa.gov*
- *Opening reception will be hosted by YPAC on Thursday, March 21, 2024 from 6-7pm.*
- *Show will run from March 21st- May 31st of 2024. (End date is subject to change)*
- *Artwork can be picked up June 1st-7th of 2024 during box office hours or by appointment.*
- *Any artwork not picked up by Aug 16, 2024 will be considered abandoned.*
